SECTION 1. PURPOSE AND INTENT

The Town Board of the Town of Stuyvesant recognizes that the prior Town of Stuyvesant local laws establishing a Code of Ethics are obsolete with respect to certain amendments to the General Municipal Law Article 18. The Town Board has determined that it appropriate and necessary to repeal such prior local laws in order re-establish a current and up to date Code of Ethics. It is the policy and intention of the Town Board to re-establish such a current and up to date Code of Ethics with the immediate enactment of a resolution consistent with said General Municipal Law Article 18.

SECTION 2.

Local Law # of 1970 and Local Law #1 of 1999 shall be and hereby are repealed.

SECTION 3. EFFECTIVE DATE

This local law shall take effect immediately upon filing in the office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.
